Special Terms and Conditions :-

- 1) The consultancy should prepare the design and decide the capacity based on population of town and prepare the plan for **Slaughter House** within the available site and get type design approval from H.M.D.A, Hyderabad.
- 2) The consultancy shall take the technical assistance of ICAR – National Research Centre on Meat during their site survey, preparation of designs, plans and estimates as they have agreed to provide the assistance in all phases of construction of this project.
- 3) The consultancy should prepare Detailed Plans, Detailed Structural Designs, Estimates, Data and conduct site survey for above mentioned work and obtain Technical sanction of the Engineer-in-Chief, Public Health, Telangana, Hyderabad.
- 4) The Consultancy should quote the Expression of Interest (EOI) on total Project estimate cost.
- 5) The consultancy should pay the EMD deposit of Rs.5,000-00 in favour of Commissioner, Bhongir Municipality in shape of DD.
- 6) The consultancy should guide during the execution of the project till the completion of the project.
- 7) The consultancy should submit the company registration documents from registering Department.
- 8) The consultancy should have PAN Card and should submit at the time of tendering.
- 9) The consultancy should have valid GST Registration and should submit the same at the time tendering.
- 10) The Detailed Project Report (DPR) should be done with in stipulated from the date of work order.
- 11) The payment will be paid to the consultancy after finalizing tenders i.e., after approval of the Estimates, Structure designs and Technical Sanction from Engineer-in-Chief, Public Health, Hyderabad, Telangana.
- 12) The consultancy should submit (5) original hard copies of approved plans, Estimate, Structured designs after Technical Sanction from Engineer-in-Chief Public Health, Telangana, Hyderabad along with soft copy.
